- Have not traveled to a highly impacted area within the United States of America in the last 14 days.
- I do not believe my children nor I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- Have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non-contagious by state or local public health authorities.
- My children and I are following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.
- I will immediately advise RWCA if any of the foregoing factors change during any time my children are attending RWCA.

I further understand that RWCA has the right to deny entry into the school should my children convey any COVID-19 symptoms, have not provided a negative COVID-19 test after the school has advised to do so, and should the children not adhere to the policy, procedures, and guidelines of the CDC and RWCA. In addition, I am aware that we should avoid large crowds, and should RWCA offer or provide any services to myself or my children, it will be contactless.

RWCA relies on the parents' cooperation to adhere to the CDC guidelines. I am aware that the school encourages and recommends parents, guardians, and caregivers to maintain their children at home should they not feel well.

I hereby release and agree to hold RWCA harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of the institution, or that may otherwise arise in any way in connection with RWCA, including acts of negligence committed by RWCA or its owners, partners, officers, directors, employees, agents, invitees, and independent contractors. I understand that this release discharges RWCA from any liability or claim that I, my heirs, or any personal representatives may have against RWCA with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any exposure to COVID-19 or otherwise. This liability waiver and release extends to RWCA together with all owners, partners, officers, directors, employees, agents, invitees, and independent contractors.
